After the transfer of vacant seats to the Deemed to be University by the Ayush Admissions Central Counselling Committee (AACCC) for Stray Vacancy Round

Eligibility Criteria:

Candidates who are included in the list of eligible registered candidates published on the AACCC website (https://aaccc.gov.in/) and have verified their credentials as Eligible for various Categories shall only be required to report for Stray Vacancy Round. In case the AACCC website publishes a second list the candidates eligible according to both lists, first and the extended can apply. No separate notice for the candidates appearing in the extended list shall be published.

Stray Vacancy Round - SCHEDULE, PROCEDURE & INSTRUCTIONS:

Eligibility for Admission to Vacant Seats: Candidates in the un-allotted list, eligible candidate list provided by AACCC for Stray Vacancy Round.

The Candidates interested in taking admission to the BAMS courses under Datta Meghe Institute of Higher Education & Research (Deemed to be University) should apply online to the Deemed University along with All India Rank and the percentile of marks obtained in **NEET** 2024. The online application form is available website www.dmiher.edu.in/www.mgachrc.org on date 13.11.2024, 11.00 am to 14.11.2024. 11.00 am server time. The Deemed-to-be University shall formulate an inter-se- merit list on the above basis, which shall be displayed on the Website on 14.11.2023. The said merit list will be referred to as DMIHER (Deemed to be University) UG Merit List- 2024-25

herein after. The selection will be done on the basis of inter se merit of the candidates who shall report for the counselling.
